This has reference to the subject mentioned above.

Amendment No. 1 to IS 7285 (Part 2): 2017 was published in June 2021. The guidelines for implementation of the above-mentioned Amendment was circulated vide note no. CMD-III/16: IS 7285 (Part 2) dated 07 July 2021. The last date of implementation of the Amendment was 02 June 2023, which was extended till 02 June 2024 as informed vide CMD-III Circular No. CMD-3/16: IS 7285 (Part 2) dated 24 May 2023.

In view of the difficulties expressed in implementation and requests received from manufacturers and users, the last date of implementation of Amendment No. 1 to IS 7285 (Part 2): 2017 has further been extended up to 02 June 2025. All BOs are advised to bring it to the notice of all Licensees and Applicants and ensure implementation of the Amendment No. 1 by 02 June 2025.

The other provisions of implementation laid down in circular no. CMD-III/16: IS 7285 (Part 2) dated 07July 2021 shall remain the same.
